REQUIREMENT FOR FRANCE TOURIST VISA

1. VISA APPLICATION FORM

You will need to complete the Schengen visa application form. It must be filled out completely and signed at the end. Be sure to complete the form accurately as incomplete or incorrect information can delay your application.

2. PASSPORT

Your passport must meet the following criteria:

Valid for at least three months beyond your intended date of departure from the Schengen Area.

Have at least two blank pages.

Should not be older than 10 years.

If you do not have a valid passport or your passport is nearing its expiration date, ensure you apply for a new one before submitting your visa application.

3. VISA PHOTOGRAPHS

You will need to provide two recent passport-sized photos that meet the following specifications:

Size: 35mm x 45mm.

Background: White and plain.

Face Visibility: The face must be clearly visible, without any shadows or obstructions.

Quality: The photos should be high-resolution, color, and printed on photo-quality paper.

Ensure that your photos are less than six months old to meet the current visa guidelines.

4. TRAVEL ITINERARY

You must provide a detailed travel itinerary for your entire trip to France. This should include:

Flight bookings: Round-trip flight reservations showing your entry into and departure from France. Ensure the dates align with your intended travel period in May 2025.

Accommodation details: Proof of accommodation, such as hotel bookings, Airbnb reservations, or a letter of invitation from a host in France (if applicable).

Daily itinerary: A brief description of your planned activities in France, including dates, places, and any sightseeing or cultural events you intend to attend.

Note: You should not purchase non-refundable flights or make non-refundable accommodation bookings before your visa is approved, as the visa may be refused.

5. PROOF OF SUFFICIENT FUNDS

You must show that you have enough financial resources to support yourself during your stay in France. This can include:

Bank statements: Recent bank statements for the last three to six months showing sufficient funds. The minimum required varies by consulate but typically is €120 per day of stay.

Sponsorship: If a family member or friend is sponsoring your trip, you must submit a Sponsorship Letter along with their bank statements and proof of relationship (such as birth certificates or marriage certificates).

Travelers' cheques or credit card statements can also serve as proof of funds.

6. TRAVEL INSURANCE

You must purchase travel medical insurance that covers:

Emergency medical expenses (including hospitalization).

Repatriation costs in case of serious illness or death.

The insurance must cover €30,000 minimum for the entire Schengen Area.

The insurance should be valid for the entire duration of your stay in France and the Schengen Area.

7. Proof of Employment/Study or Business

If you are employed, a student, or running a business, you need to provide supporting documents that explain your current occupation and ties to your home country:

For employees: A letter from your employer, stating your position, salary, and the dates of your approved leave.

For students: A letter from your educational institution confirming your enrollment and expected return.

For business owners: A copy of your business registration and a letter stating that you will return to manage your business.

8. COVER LETTER

A personal cover letter explaining:

Purpose of travel: Why you are traveling to France, including details about your trip.

Travel dates: Your planned entry and exit dates.

Itinerary: A brief description of your travel plans and accommodation.

Assurance of return: A statement explaining your intention to return to your home country after your visit (especially if you are employed or studying).
